

The undersigned, desiring to form a corporation, not for profit, under Sections 1702.01 et seq. of the Ohio Revised Code, do hereby state the following:

- e. Promote and strengthen a spirit of comradeship among its members.
- f. Carry out any other act or thing incidental to or connected with the foregoing purposes or on advancement thereof, but not for the pecuniary profit or financial gain of its members, directors, or officers.




